## Amendments to the **Public Service Act of 1936**

## Multiple Sectors

#### Description

Seeks to address the confusion in the definition of a public utility and public services, which, for several decades, hampered economic growth and foreign investment. It will provide clear definition of public utilities, which will be limited to the following natural monopolies: 1) Distribution of electricity; 2) Transmission of electricity; 3) Water pipeline distribution; and 4) Sewerage pipeline. With this reform the 60-40 rule will no longer be applied to foreign investment in public services.

President Duterte certified the measure as urgent on April 12, 2021.

# Executive Order 116 – Creation of Nuclear Energy Program Inter-Agency Committee

## **POWER**

#### Description

In July 2020, President Rodrigo Duterte signed Executive Order (EO) 116, directing a study on the feasibility of introducing nuclear energy to the Philippines' power generation mix. The EO creates the Nuclear Energy Program Inter-Agency Committee (NEP-IAC) which will be tasked to "revisit the country's policy on nuclear energy and to determine its feasibility as a long term option for power generation."

The NEP-IAC will be chaired by the Secretary of the Department of Energy with the Secretary of the Department of Science and Technology as vice chair. Members of the NEP-IAC will be composed of representatives from the Departments of Environment and Natural Resources, Interior and Local Government, Finance, Foreign Affairs, National Economic and Development Authority, National Power Corporation, National Transmission Corporation, Philippine Nuclear Research Institute and Philippine Institute of Volcanology and Seismology.

The NEP-IAC will evaluate and formulate a national strategy to include a roadmap and timeline in the preparation of a Philippine Nuclear Energy Program. It will also review the existing legal framework, study the viability of nuclear energy, and recommend the necessary steps in the utilization of nuclear energy, as well as existing facilities like the Bataan Nuclear Power Plant.

# 100% foreign ownership in large-scale geothermal exploration, development, and utilization projects

## **POWER**

#### Description

The Philippines is now allowing 100% foreign ownership in large-scale geothermal exploration, development, and utilization projects. Foreign companies may now have the exclusive right to develop a geothermal resource under the Third Open and Competitive Selection Process (OCSP3) in the awarding of renewable energy service contracts subject to the following conditions:

- It should be large-scale, with a minimum investment cost of US\$50 million, and
- It should be under Financial and Technical Assistance Agreement as provided under the Constitution.

# Moratorium of Endorsements for Greenfield Coal-Fired Power Projects

## **POWER**

#### Description

In December 2020, the Department of Energy issued an advisory on a moratorium of endorsement of applications for new greenfield coal-fired power plants. A recent review of the country's power mix revealed the need to increase the share of renewable energy resources and to accommodate the entry of new, cleaner, and indigenous technological innovations.

Existing and operational coal-fired power generation facilities as well as committed and existing projects with expansion plans will not be affected by the advisory.

## **Road Board Abolition**

# Roads and Railways

#### Description

The bill seeks to abolish the Road Board which was created by RA 8794 to administer tax revenue from vehicle registration fees to be used to repair and upgrade the nation's roads. However, the funds – currently at PhP 45 billion - were often spent and misspent without proper oversight or Congressional appropriation. Legislation to abolish the Road Board passed both Senate and House in 2018, but the House withdrew its approval under the new leadership of Speaker Arroyo.

# Amendments to RA 7925 or the National Telecommunications Commission Charter (NTC)

## **Open Access in Data Transmission Act**

## Telecommunications

#### Description

The bill will lower barriers and cost to entry for data service providers and promotes sharing of infrastructure and efficient use of resources. It aims to bridge the broadband infrastructure gap in the Philippines by bringing in more players in the data transmission sector. The bill also removes the need for a congressional franchise for telecom companies.

DICT is reportedly planning to recommend presidential certification as urgent after final House approval.
